Free License for the use of the OSEK/VDX-Standard

The undersigned companies are OSEK/VDX Partners or Associated Partners of the OSEK/VDX Consortium. To further the use of the OSEK/VDX Standard the OSEK/VDX Partners and Associated Partners offer - subject to the return of the countersigned confirmation letter enclosed as in Annex 1 to this declaration by the respective third party (hereinafter referred to as "Licensed User") - on copyrights, on patents and other industrial property rights owned by one or more of the OSEK/VDX Partners and Associated Partners a non-exclusive royalty-free license to the Licensed User, its holding companies, subsidiaries and other subsidiaries of its holding companies ("Affiliated Companies") to use the specification defined by the OSEK/VDX Standard as detailed in Annex 2 to this declaration for the implementation of the OSEK/VDX Standard or parts of it in products. If necessary for the implementation of the OSEK/VDX Standard the OSEK/VDX Partners and Associated Partners will cause their Affiliated Companies to grant a similar license to the Licensed User.

For the avoidance of doubt: Not included are technologies, industrial property rights, copyrights or components, which are not specified in Annex 2 but which may be used in connection with OSEK/VDX implementation in products.

This license is granted subject to the Licensed User and its Affiliated Companies granting to the OSEK/VDX Partners including their Affiliated Companies and to the Associated Partners including their Affiliated Companies and to other Licensed Users of the OSEK/VDX Standard and their Affiliated Companies a non-exclusive, royalty-free license on copyrights, on patents and other industrial property rights to use the specification defined by the OSEK/VDX Standard as detailed in Annex 2 to this declaration for the implementation of the OSEK/VDX Standard or parts of it in products. The Licensed User shall cause its Affiliated Companies to grant a similar license if necessary for the implementation of the OSEK/VDX-Standard.

The OSEK/VDX Standard comprises:

- 1. the OSEK/VDX network management,
- 2. the OSEK/VDX communication system,
- 3. the OSEK/VDX certification and
- 4. the OSEK/VDX operating system.

The termination of this Agreement by a OSEK/VDX Partner, Associated Partner or Licensed User shall have no impact upon this Agreement with respect to the not terminating OSEK/VDX Partners, Associated Partners or Licensed Users. The licenses granted to the terminating OSEK/VDX Partner, Associated Partner or Licensed User shall expire at the date of termination, but the licenses granted by the terminating OSEK/VDX Partner,

Associated Partner or Licensed User until the date of termination shall remain valid unlimited in time.

The terminating OSEK/VDX Partner, Associated Partner or Licensed User shall loose the right to take a free license on the OSEK/VDX Standard for five years from the date of termination.
